

Cookie Policy

When you visit our website, we automatically collect a certain amount of information through the use of Cookies. This Cookie Policy provides you with a range of information to inform you about how we collect this data and how we use it.

1. General Principles

- 1.1. The website uses Cookies to distinguish the Website's Users in order to provide them with a better browsing experience and to optimise the Website and its content.
- 1.2. A "Cookie" is a data or text file temporarily or permanently installed on the User's device (computer, tablet, smartphone, or any other similar device) when using the Website, with a view to later connection. Thanks to Cookies, the server recognizes the User's computer. Cookies can retain User settings and other data (choice of language, IP address, connection data, etc.), but they do not save any names, addresses, ages, or other personal information.

Cookies may also be installed by third parties with whom ICHEC Junior Consult collaborates.

- 1.3. Certain Cookies used by ICHEC Junior Consult are necessary for the good functioning of the Website, while others allow to improve the User's experience.
- 1.4. When using the website, the User agrees to the use of Cookies. The Data Controller uses the following Cookies:
 - 1.4.1. Strictly necessary Cookies: the essential Cookies to enable the User to navigate the website and to use all of its functionalities. Without

these Cookies, services such as online registration forms cannot be provided.

- 1.4.2. Tracking Cookies: Cookies that collect the data on how Users use the Website (most visited webpages, error messages, etc.). These Cookies do not collect any data that would enable identification of the Internet User and are only used in order to optimize the Website's functioning.
- 1.4.3. Functionality Cookies: Cookies enabling the Website to save the User's choices and provide them with better functionalities. The data collected by these Cookies can be anonymised and cannot be used to follow the User's browsing activity on other websites.
- 1.5. The User can edit or deactivate Cookies by configuring their browser according to point 4 of this article.
- 1.6. By using the website, the User expressly agrees with the management of Cookies as described in this article.

2. Types of Cookies and purposes

Different types of Cookies are being used by ICHEC Junior Consult on their Website.

- Technical Cookies: they are necessary for operating the Website, they allow the communication of the data shared and are intended to facilitate the User's navigation. Without these Cookies, services such as online registration forms cannot be provided.
- Statistics and audience measure linked Cookies: these Cookies allow the recognition of a User and are used to count the number of Users on the Website during a certain period of time. Since they indicate the User's behaviour, they are an efficient way to improve the User's browsing by displaying proposals and offers that may be of interest to them. They also

enable ICHEC Junior Consult to identify eventual Website malfunctioning and to fix them.

- Functional Cookies: these Cookies facilitate the Website use by remembering certain choices introduced (such as the User's name or language).

3. Cookies' conservation period

This period shall not exceed the required amount of time to achieve the pursued purposes with a maximum period of thirteen months.

4. Cookies' management

- 4.1. In the event the user wishes the website does not place any cookies on their hard drive, it is easy for him/her/them to manage or remove cookies by changing his/her/their navigator's settings. Programming the navigator not only enables the user to be notified whenever the website uses cookies but also to consent or decline such use of cookies.
- 4.2. If the user deactivates specific cookies, they accept that the website might no longer work optimally. Some parts of the website might, therefore, not be accessible or only partially.
